


1: What are the key benefits for us deciding to join FCAT as their Rural Hub Lead School?

- Provide long -term security ("bubble wrap") for our school as we move forward to a financially and educationally turbulent & challenging future
- Positive recognition for what Team GCA has achieved on its journey so far
- A new deep collaboration, based on a shared local ethos, could further strengthen education in our community, benefitting our young people and their families
- We have an opportunity to choose our future partners on our terms rather than have them chosen for us on someone else's terms.



2: What will it mean for us to lead a Rural Hub for FCAT?

- Work more closely and more collaboratively with other likeminded local schools
- As Hub Lead, ensure that partner schools support each other successfully on their improvement journeys

3: What would stay the same, if the proposal were to go ahead?

- Our values, mission and vision would remain the same, as we are very closely aligned already to FCAT's Core Values & Mission (see FCAT web site)
- Our school name, uniform, branding, school day, term dates, staff pay and conditions, the everyday experience for parents, students and staff would stay the same!

4: What would change, if the proposal were to go ahead?

- The business operation of Garstang Community Academy Trust would merge with that of FCAT from 1/9/17, with all GCA staff becoming employees of FCAT whilst retaining their existing Terms and Conditions
- Over time, some mutually beneficial administrative, finance and curriculum systems would be integrated
- 5: What does the consultation process concerning the proposal look like?
- Key stakeholders (e.g. staff, parents, Governors) will be consulted from 24/1/17, and invited to make representations by 9/3/17, when the consultation period comes to an end
- Governors will meet on 16/3/17 to consider stakeholder representations and decide whether or not the proposal should proceed


FAQs:
